2. I will not physically abuse, neglect, starve, or harm the pet in any way.
3. I will keep my pet up-to-date on all vaccinations.
4. I will make sure that the pet has enough food and water to maintain a healthy weight.
5. I will make sure that the pet has adequate shelter.
6. I will ensure that the pet gets the necessary requirement of daily exercise.
7. I will never let my pet outside unless they are wearing proper identification.
8. I will obey all laws concerning leashes and waste removal.
9. If the ownership does not work out, I agree to offer the pet back to the seller at no cost, agreeing to sign back over registry papers (if any) before seeking other placement. The seller will have 21 days after initial notification to reacquire the pet or choose to help the buyer re-home the pet.
10. I, as the buyer, understand that there will be no refund of any kind (whole or partial) if ownership does not work out. This includes if the seller chooses to re-sell said pet.
11. I will pay the purchase price of \$\_\_\_\_\_ upon pick up.
12. I understand that no guarantee is made regarding the overall health, genetics, coat quality, breeding capability or temperament of this pet and the seller will not be held accountable once ownership has transferred to the buyer. I acknowledge there is no guarantee of any kind regarding these issues and am purchasing the pet 'as is.'
13. I understand that the seller is not liable for any action (of any kind) taken by the pet.
14. I understand that the seller is not responsible for any vet costs/bills or any other costs incurred by the buyer once ownership has been transferred to the buyer. This includes if ownership does not ultimately work out and the pet is returned to the seller. If the seller re-sells the pet, there will be no reimbursement of any vet costs/bills or any other costs
